How to write a cause and effect essay

لها 3 خطوات..

Step one "الخطوة الاولى"

.Select a significant topic, for example, a social phenomenon or a social trend

"اختيار موضوع مهم، مثال، ظاهرة اجتماعية أو الاتجاه الاجتماعي"

Examples: "أمثلة"

Social phenomena: "الظواهر الاجتماعية"

Teenage rebellion "تمرد في سن المراهقة"

Teenage violence "العنف في سن المراهقة"

Domestic abuse "الاعتداء المنزلي"

Environmental crisis "الأزمة البيئية"

Pollution "التلوث"

Social trends: "الاتجاهات الاجتماعية"

Increasing number of teenage pregnancies "زيادة عدد حالات الحمل بين المراهقات"

Increases in computer science majors. "الزيادات في تخصصات علوم الكمبيوتر"

Step two "الخطوة الثانية"

.Decide whether you want to examine the cause or effect or both

Step three "الخطوة الثالثة"

.Examine each cause and effect thoroughly, using sufficient evidence to prove your points
