- The origin of the word 'translation' is the Latin word 'translatus'
- The dictionary meaning of the English verb 'to translate' is 'to express or be capable of being expressed in another language or dialect.
- o one looks at it as an 'art' especially when the scholars of last century were preoccupied with the translation of literary text as a pastime
- What is a Good Translation?
 - ""that in which the merit of the original work is so <u>completely transfused</u> into another language, as to be as <u>distinctly apprehended</u>, and as <u>strongly felt</u>, by a native of the country to which that language belongs, as it is by those who speak the language of the original work."
- Newmark (1982): defines it as "a craft consisting in the attempt to replace a written message and/or statement in one language by the same message and/or statement in another language".
- According to Bell, a good translation is "that in which the merit of the original work is so completely transfused

into another language, as to be as distinctly apprehended

Lecture 02

- we can say that any model of communication is a model of translation.
- It is the **re-encoding process** which marks the bilingual translator off from the monolingual communicator.
- **Memory** : contains 'records' of past experiences, has plans for action on the basis of what we know and what we have done.
- o Translators must be good at storing experiences in memory, and at retrieving those experiences whenever needed to solve complex translation problems.
- Grammatical competence: knowledge of the rules of the code, including vocabulary and word formation, pronunciation/spelling and sentence structure.
- What are the primary characteristics of a good translator?
 - Reliability Timeliness Ethics Speed Memory Professional Pride
 - A professional translator has access to five distinct kinds of knowledge:
 - 1. Target Language knowledge (TL)*
 - 2. Text-Type knowledge*
 - 3. Source Language knowledge (SL)*
 - 4. Subject-area knowledge*
 - 5. And contrastive knowledge*

- The English word **theory** was derived from a technical term in Ancient Greek philosophy.
- In modern science the term "theory", or "scientific theory" is generally understood to refer to a proposed '<u>explanation</u>' of <u>empirical phenomena</u>'
- **Theory**: It exists in the mind.

 - 1. Empiricism It must be testable.
 - 2. Determinism It must be able to predict
 - 3. Parsimony It must be simple
 - 4. Generality It must be comprehensive
- The Definition of a Model
 - A model is, in contrast, an external rather than an internal representation of the explanation; a realization of the theory.
- A theory of translation as both process and product

 - It is the language to which the text to be translated belongs.

- What is the Process of Translation?
 - It is a complex cognitive operation which takes place in the mind of the translator.

- Word-for-word translation
 - interlinear translation
- Literal translation
 - The SL grammatical constructions are converted to their nearest TL equivalents but the lexical words are again translated singly, out of context.
- Semantic Translation
 - Faithfull translation is uncompromising and dogmatic while Semantic translation is more flexible
- Adaptation
 - plays(comedies), poetry stories, where the themes
- Free Translation
 - It is usually a paraphrase much longer than the original.
- o Idiomatic Translation
 - affixed figurative expression
- **Communicative** Translation
 - render the exact contextual meaning of the original
- Only semantic and communicative translation fulfil the two main aims of translation, which are first accuracy and second economy

- Ecology : flora, fauna, winds, plains, hills; 'honeysuckles', 'downs', 'plateau'
- **Material culture**: (artefacts) (food, clothes, houses and towns, transport).

Lecture 08

- Islam almost looks at Learning a foreign language as a religious duty.
- o Muhammad, The Prophet of Islam, (PBBUH) sent a message to Hercules, a Roman military leader at that time, written on a piece of animal skin.
- o Works on philosophy, medicine, engineering, music and logic were translated from Greek into Arabic
- while works on astronomy, art, law, history and music were translated from Persian into Arabic
- Yūĥanna bin Batriq's method, the literal way
- **Ĥunayn bin Isĥaq's method** the free way
- When Napoleon Bonaparte invaded Egypt in 1789, he brought along with him translators and interpreters to help him communicate with Egyptians with regard to political, social and administrative affairs.
- Translation took the form of an independent movement & thrived as **Muhammad Ali** was very interested in learning about European civilization.
- it would be no exaggeration to call Muhammad Ali's time "The Period of translation".
- When Arab learning declined, Toledo in Spain replaced Baghdad and started to attract the attention of Western translators.
- As the works held in Toledo were in Arabic, and of a Greek origin, translators started to translate from Arabic into Latin

- Interpretation was used **before** translation as a means of communication between people of different languages.
- Mechanical aids:
 - This involves the use of type-writers, dictating machines, photocopying machines, etc.
- Conference interpreting:
 - It was born during World War 1 & held in French.
- Other forms of interpreting include:
 - 1. Business Interpreting
 - 2. Court Interpreting
 - 3. Community Interpreting
 - 4. Signed Language Interpreting
- The focus in interpretation is generally on ideas.
- The time in **interpreting** is crucial
- Simultaneous Interpretation:
 - In this kind of interpretation, the interpreter listens to what is being

said and then translates it orally and simultaneously into the TL.

Lecture 10

- What is Translation Memory Technology (TM)
 - TM allows the translator to store translations in a database and 'recycle' them in a new translation by automatically retrieving matched segments

(usually sentences) for re-use.

- The word is "the smallest unit of language that can be used by itself."
- Idioms and fixed expressions
 - are frozen patterns of language which allow little or no variation in form and in case of idioms, often carry meanings which cannot be deduced from their individual components

Lecture 12

- **Grammar** is the set of rules which determines the way in which units such as words and phrases can be combined in a language.
- Grammar is organised along two main dimensions morphology and syntax
- o Morphology
 - covers the structure of words, the way in which the form of a word changes to indicate specific contrast in grammatical system
- o Syntax
 - covers the grammatical structure of groups, clauses and sentences: the linear sequences of such classes of words, such as nouns, verbs, adverbs and adjectives, and functional elements such as subject, predicator and object which are allowed in a given language.
- The form of the verb in such languages indicates two main types of information: time relations and aspectual differences
- Arabic , for example, unlike English have a dual form in addition to singular and plural form.
- The category of person relates to the notion of participants roles.
- Tense and aspect are grammatical categories in a large number of languages.

Lecture 13

- AlJundi (1982) makes a distinction between culture and civilisation: "the former involves beliefs, customs, traditions, laws, value-systems, etc. Whereas the latter generally involves progress and development at the level of scientific inventions, technology, industries, education, etc."
